

As spring approaches and the weather gets warmer, we always experience a seasonal increase in calls for service and overall activity.

#### To Reduce the Risk of Burglary, here are a few tips to help you secure your home:

- All outside doors should be made of solid wood or metal construction.
- Replace worn out window hardware such as latches, locks, screws, and pins.
- All outside doors and inside garage doors should have at least one-inch deadbolt locks.
- Strike plates should be affixed to the door frame with minimum of two fully threaded 3inch screws.
- All entry points should be illuminated and clear of obstruction.
- Keep valuables out of sight from windows.
- Keep porch and outdoor lights on all night.

As a friendly reminder, please keep your grass and weeds under seven (7) inches, and your property clear of junk, trash, and/or debris to ensure you are not issued a codes citation.

## NATIONAL WEATHER SERVICE

### Tornado Safety

<u>Tornado Watch</u>— Issued when conditions for tornado development. People located in and around the watch are should be weather aware and listen to their NOAA weather radio or local broadcast media for further weather information. A "Tornado Watch" is intended to give you time to prepare and time to review your safety rules.

<u>Tornado Warning</u> – Issued when a developing tornado has been detected by National Weather Service (NWS) doppler radar or a reliable report of a tornado has been reported. The tornado warning is usually issued for portions of one or two counties, for an hour or less. The storm could also produce large hail and destructive straight-line winds. If the tornado warning includes your neighborhood or workplace, seek shelter immediately.

In the event of a tornado, here are some tornado safety rules to help keep you and your family safe;

- In general, get as low as you can. A basement below ground level or the lowest level of a building offers the
  best protection. Put as many walls between yourself and the outside as possible. Avoid windows.
- Tornados could be obstructed by rainfall or come at night. Do not wait until you see or hear the tornado. It may be too late.
- In homes or public buildings, go to the basement or a small interior room, such as a closet, bathroom or
  interior hallway on the lowest level. Close all doors to the hallway for greater protection. Protect yourself
  from flying debris with pillows, heavy coats, blankets or quilts.
- Don't stay in a mobile home during a tornado. Mobile homes can turn over during strong winds. Go to a nearby building, preferably one with a basement. If there is no time to get to a shelter, lie flat in the nearest ditch, ravine, or low spot. Lie flat, covering your head with your hands for protection.
- In vehicles or outdoors; when tornadoes are possible, stay close to a sturdy shelter. If caught outside, find
  shelter in a ditch or remain in your vehicle and cover your head for protection. Do not take shelter under a
  highway overpass, where wind speeds can increase due to a tunneling effect. It is best to not put yourself or
  others in a situation where no sturdy shelter is available
- Remember, stay away from doors, windows, outside walls and protect your head.

#### City of Pleasant Valley Missouri Meeting of the Board of Aldermen February 19, 2024, at 6:32 pm

Call to Order: A regular session meeting of the Pleasant Valley Board of Aldermen was called to order at City Hall, 6500 Royal Street, Pleasant Valley, Missouri, by Mayor James Smith, on Monday, February 19, 2024, at 6:32 p.m. Copies of the agenda, minutes, and council bills to be considered were available in the lobby for public inspection prior to the meeting.

Consent Agenda: Alderwoman Jacoby moved to approve the consent agenda. Alderwoman Ohlsen seconded the motion. The vote was as follows: Gallagher – aye, Mesimer – aye, Jacoby – aye, Scarborough – aye, Page - aye, Moss – aye, Langner – aye, and Ohlsen – aye, Motion passed 8 ayes, 0 nays. Public comments and guests: Robert de la Fuente (Star Development) and Joseph Lauber (Lauber Municipal Law) were in attendance to provide a status update to the project at 8601 Pleasant Valley Road. Mr. de la Fuente stated that the original list of 12 possible sites had been narrowed to 4 of which the Pleasant Valley location was one of the final four. The proposed 135,000 square foot building would cost approximately \$80 million to build. The other three finalist sites are in Kansas City, Missouri and building costs would likely be higher for those sites. The backup plan is the Pleasant Valley site is not chosen remains an apartment building. No changes are planned for the site until a final plan is confirmed. Alderwoman Mesimer asked what the change to a Veteran's Administration clinic would mean to the Tax Increment Financing (TIF) Plan already in place. Mr. Lauber stated that the city has 10 years before the TIF Plan must be activated. Mr. Lauber stated that if the VA clinic is approved, the city might need to go back through the hearing process.

Aldermen Comments: After some discussion, the Board of Aldermen decided to reschedule the Budget Meeting for Friday, March 1st at 1:30 pm in the council chambers.

#### Advisory Committees / Department Reports:

City Clerk, City Clerk, Matthew Chapman, provided a written administration report to the Board of Aldermen.

Public Works Department: Public Works Director Chris Cronk stated that the city has received the signed easement documents from Shawn Majidi, which will allow the city to put the Kaill Road project out for bid. Quik Trip is wrapping up their remodel and work should be completed by the end of March.

Fire Department: Assistant Fire Chief Phil Hudson stated the Fire department responded to 44 calls in December and 40 calls in January. There were 2 fire calls in January, one at the Claycomo Ford Plant and the other at the concrete plant.

Police Department: Police Chief McGinley stated that the dispatch supervisor had turned in her two-weeks' notice and because the department would be short-staffed until a replacement was found, Chief McGinley might need to pick up dispatcher shifts. Chief McGinley requested to temporarily remove the 95-hour restriction he had agreed to when he was named Police Chief.

Municipal Court: Court Administrator Sarah Everhart stated that the court was in the middle of the amnesty period to clear up warrants and 57 people had taken advantage.

Call to Order: A regular session meeting of the Pleasant Valley Board of Aldermen was called to order at City Hall, 6500 Royal Street, Pleasant Valley, Missouri, by Mayor James Smith, on Monday, March 4, 2024, at 6:32 p.m. Copies of the agenda, minutes, and council bills to be considered were available in the lobby for public inspection prior to the meeting.

Consent Agenda: Alderwoman Jacoby moved to approve the consent agenda. Alderwoman Ohlsen seconded the motion. Prior to the vote, Alderman Moss noted that the minutes did not include a note stating that the city attorney recommended that Alderman Gallagher abstain from voting on an issue that affected fire department personnel which included his wife. After more discussion, the Board of Alderman agreed that an amended Consent Agenda including the statement from the city attorney should be considered. Alderman Scarborough moved to approve the amended consent agenda. Alderwoman Ohlsen seconded the motion. The vote was as follows: Gallagher — absent, Mesimer — aye, Jacoby — aye, Scarborough — aye, Page - aye, Moss — aye, Langner — aye, and Ohlsen — aye, Motion passed 7 ayes, 0 nays, 1 absent. Public comments and guests: Fire Fighter/EMT Aspen Pruchnik spoke in support of the proposed raises for Fire Department personnel. Ms. Pruchnik stated that any call could be the last call. Fire Department personnel are paid less than \$200 per 12-hour shift which is barely more than minimum wage to run into

burning buildings. Mayor Smith stated that everyone would get their one step raise, but there would be no more blanket, across the board raises.

City Attorney and other professional services: City Attorney Tom Capps stated that according to state statute a council member would be allowed to vote on issues where direct family members were affected if the issue being voted on involved a larger class of employees.

Mayor's comments: None

Aldermen Comments: Alderwoman Languer stated that the Parks and Recreation Board still has two vacancies.

#### Advisory Committees / Department Reports:

City Clerk: City Clerk Matthew Chapman provided a written administration report to the Board of Aldermen.

Public Works Department: Public Works Director Chris Cronk provided a written administration report to the Board of Aldermen.

Fire Department: Fire Chief Pete Knudsen asked the Board of Aldermen for approval to send Fire Marshall Scott Winfrey to Fire Investigator class to be held in April in Jefferson City, Missouri. The class would consist of 40 hours online and 40 hours of classroom training. The class is free, but the city would need to pay for the hotel and mileage reimbursement for Mr. Winfrey.

Alderman Moss moved to approve Fire Marshall Scott Winfrey to attend Fire Investigator class in Jefferson City, Missouri with total cost not to exceed \$1,000. Alderman Scarborough seconded the motion. The vote was as follows: Gallagher – absent, Mesimer - aye Jacoby – aye, Scarborough – aye, Page – aye, Moss – aye, Langner – aye, and Ohlsen – aye, Motion passed 7 ayes, 0 nays, 1 absent.

Chief Knudsen stated that the cost of the ambulance the city has ordered has increased by\$11,500 due to the 2022 chassis no longer being available. Chief Knudsen stated that the City of St. Louis has placed an order for 10 ambulances but does not have an urgent need for the whole order and Pleasant Valley could take one ambulance that is part of that order and likely receive the vehicle in February or March of 2025. The Board of Aldermen agreed to accept an ambulance from the St. Louis order in an effort to get the ambulance sooner.

Police Department: Police Chief McGinley stated he was glad the dispatch supervisor had decided to stay after turning in her resignation but changing her mind. Alderman Scarborough asked if the Board of Aldermen needed to rescind the removal of the 95-hour limit per pay period restriction approved at the February 19th meeting. Chief McGinley stated that he would like to leave the removal in place for now and the Board of Aldermen agreed.

Municipal Court: Court Administrator Sarah Everhart the Court Clerk, Lisa Ruyf, had submitted her resignation because she needed full-time employment. Ms. Everhart stated that she had met with Clerk Chapman about the possibility of Ms. Ruyf continuing to work part-time in the court and adding part-time hours in the Administration Department as an administrative assistant that would result in full-time employment with the city. The Board of Aldermen stated that they would discuss the matter during the closed session.

2 Tbsp. butter 2 cups soft bread crumbs 1/2 cup sugar 1/4 tsp. cinnamon 1/4 tsp. Nutmeg 1 lemon, rind and juice 3 cups apples, chopped 1/4 cup water

Melt butter and add the crumbs. Mix the sugar, spices, and grated lemon rind. Put one quarter of the crumbs in the bottom of a buttered baking dish. Cover with half the apples. Sprinkle with half the sugar mixture; then add another quarter of the crumbs, the remainder of the apples, and the rest of the sugar mixture.

Add the lemon juice and the water, and put the rest of the crumbs over the top.

Cover, bake 45 minutes at 375 degrees, uncover and brown Serve with whipped cream Crushed cornflakes may be used in place of bread crumbs. Serves 8.
