JOB SUMMARY STATEMENT:

Performs duties, both in emergency and non-emergency situations related to firefighting, first aid, hazardous materials response, and emergency management delivery.

DUTIES AND RESPONSIBILITIES:

- 1. Perform Basic Life Support care as required and defined by medical protocol.
- **2.** Respond to alarms, protect lives and property through prevention and extinguishment of fires, as well as assisting in the preservation of evidence to determine the cause of fires.
- **3.** Respond to alarms and properly perform according to the departments standard operating procedures.
- **4.** Meet all established minimum eligibility requirements such as successful completion of a background check, successful completion of written, oral and physical agility test, a physical and drug screen.
- **5.** Participate in group and individual training and drill sessions relating to firefighting, emergency medical services, rescue and related topic areas.
- **6.** Participate in public education programs by assisting in conducting fire department tours, demonstrations, and presentations.
- **7.** Assist in general maintenance work assigned apparatus and fire station.
- **8.** Assist as necessary in maintaining the cleanliness and safety of the fire station.
- **9.** Perform related work as required or assigned.
- **10.** Attend all fire department meetings and all training courses related to first-aid, firefighting, fire prevention, rescue operations and hazardous materials.
- **11.** Maintain the minimum training and attendance requirements per departmental standard operating procedures.
- **12.** Participate in all rescue operations including, high angle, confined space, auto extrication, and building collapse.
- **13.** Drive all emergency vehicles operated by the department.

14. Assist in maintaining all apparatus and tools of the department, including non-powered tools such as axes, pike poles, ladders and other miscellaneous equipment.

- **15.** Participate in fire inspections enforcing the current city adopted Uniform Fire Code, identify target hazards and establish actions to be taken at an incident.
- **16.** Respond to hazardous material incidents and assist in identification.
- **17.** Participate in Emergency Management functions.
- **18.** Conduct ones self in a mature, professional and courteous manner at all times.
- **19.** Other duties as assigned.

The above duties and responsibilities include those tasks, physical and mental requirements, visual requirement, unique physical surroundings and mental/cognitive abilities required to perform the essential elements of the position.

- **b)** Knowledge of medical system protocol for EMT's / First Responder
- c) Knowledge of street system, principal buildings, business districts and physical layout
- **d)** Knowledge of departmental standard operating procedures.
- e) Knowledge of incident command.

5. Physical Requirements -

- **a)** Must have physical capability of climbing, stooping, crawling, bending and other repetitive moves.
- **b)** Must be able to walk over uneven surfaces
- c) Must be capable of lifting at least 100 pounds
- **d)** Working for long periods of time while wearing personal protective equipment that weighs approximately 30-40 pounds
