A. The fee for the issuance of each permit is as follows:

1. For a peddler acting on behalf of a business otherwise licensed to do business within the City, and whose business is located within the City of Pleasant Valley, Missouri, the fee is five dollars (\$5.00) per day.
2. For a peddler acting on behalf of a merchant otherwise licensed to do business within the City, and whose business is located outside of the City limits of Pleasant Valley, Missouri, the fee is twenty-five dollars (\$25.00) per day.
3. For a peddler acting on behalf of a business not otherwise licensed to do business within the City, the fee is thirty-five dollars (\$35.00) per day.
4. The applicant must pay in advance for each day he/she plans to peddle within the City. The permit will be issued for the number of days paid in advance and will then expire.
5. Issued permits shall not exceed fourteen (14) calendar days. Upon expiration of the permit, the peddler may reapply for a new permit.
6. The number of individual peddler's permits allowed in the City at any one (1) time is six (6).

You must pay in advance for each day you wish to peddle within the City. If your Application is approved, you will receive a permit valid for the number of days you pay for up front. At the expiration of said term, you may return to the City Clerk and seek renewal of the permit by paying for additional days at the same rate. How many days do you intend to peddle within the City? _____
